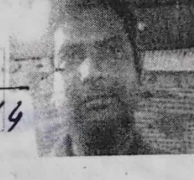

And whereas the trustees have, at the request of the Settlor, agreed to act as the first trustees of these presents as testified they are being parties to and executing these presents.

And whereas it is necessary to declare the aims and objects of the public charitable trust, being constituted under these presents.

Now this indenture witnesses as follows:

That, to effectuate his aforesaid desire, the Settlor has set apart and handed over to the trustees, a sum of **Rs. 2,01,000/- (Two Lakh One Thousand only)** hereinafter called the "Trust Fund" which expression shall include cash and any other property of investments of any kind whatsoever in to which the same or any part thereof might be converted, invested or varied from time to time which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisos, agreements and declarations hereinafter contained.

That the name of the trust shall be **JAGESHWAR MAHTO MEMORIAL TRUST** it will be also known as **JMMT** and the office will be situated at **REGD. OFFICE:- Vill- Sikahar, P.o-Buniyadgunj, P.s-Mufassil, Dist- Gaya- 823003, [BIHAR]** and/or its branches at such other place or places as the trustees may decide from time to time.

That the objects for which this trust is established are:

I. In the field of Leadership Development:-

- a) To establish organizations, institutions, and platforms to create and help create leaders in all fields in India who will dedicate themselves to public service and nation-building.



- b) To establish, maintain and run organizations, institutions, and platforms to further create opportunities and provide service in the field including but not limited to education, health care, and finance.
- c) To establish, develop, maintain technical and non-technical institutions, industrial training centers, schools, colleges, libraries, universities, medical college, nursing & paramedical college, Ayurveda medical college, Homeopathic Medical College laboratories, skill development centers, spiritual centers, sport training centers, vocational training centers, research centers, and other institutions for the development and advancement of education and diffusion of knowledge among the public in general.
- d) To organize programmers for the promotions of pre- primary education, non-formal education, computer & information technologies, leadership development, techno-entrepreneurship development educational, infrastructure research and development, socio-scientific research, and management.
- e) To create textual, audio, and video content for education and awareness.
- f) The trust shall purchase, acquire, establish, and maintain movable and immovable properties for achieving its said objectives.
- g) The trust may also receive donations and contributions of movable and /or immovable assets as trust property for retention, maintenance and use by the trust.
- h) To organize, promote, undertake, sponsor, carry-out all programmes for the benefit of naturally- challenged persons, people under the poverty line, old-aged, widowed, orphaned, and other downtrodden without discrimination of any sort.

II. In the field of Health & Social welfare:-

- a) To undertake, establish, assist, organize, or conduct the programme of research, management, and infrastructure development in the field of health & family welfare.
- b) To establish, organize, run or maintain hospitals, nursing homes, care centers, all type or medical education, and research centers.

- c) To establish institutions and design and run programmes for the prevention of disease and improvement of quality of life in society.

III. In the field of Public Health and Environment:-

- a) To establish, run, and maintain effective institutions, organizations, and programmes that positively impact the environment and ensure a better quality of life.
- b) To undertake all programmes for ensuring social accountability in conservation, preservation, and control to the environment, forest, and wildlife.
- c) To undertake awakening and intervention programmes for enforcement of environmental laws, access to environmental information, town and country planning, integrated pollution control, atmospheric pollution, waste management, water pollution, sound pollution, and other such conservation programmes.

IV. In the field of Youth Affairs and Sports:-

- a) To build institutions and programmes for preparing young leaders and scholars in all academic and non-academic fields.
- b) To organize and install infrastructure for the development of sports, yoga, meditation, and world – class skill development among youth.

V. In the field of Science & Technologies and Communication & Information Technologies:-

- a) To carry out all programmes to promote the use of technologies in the field of leadership development, rural development, education, health, environment, ecology, etc.
- b) To organize and set the infrastructure for the promotion of entrepreneurship through structured training programmes and other facilitation mechanisms.
- c) To promote research development and adaptation of science and technology for improving the quality of life of traditional artisans, landless labours and other or sections of the society.

VI. In the field of Other Programmes:-

- a) To undertake, organize, investigate, participate, sponsor and conduct for the awakening of human rights, preservation of fundamental rights, protection and safeguarding of the victims of human rights, violations, for the freedom, dignity, and peace of people and also undertake case studies, research, publications, treaties, with national and international institutions and foundations or endowment of award and prize, for effective implementation of Human Rights.
- b) To organize or conduct programmes for International peace, Justice, and co-operation.
- c) To do all activities which are mentioned under section 2 (15) of income tax act 1961 or similar law.
- d) And to participate in all emerging issues, whenever occurs in the national and/or international arena and to do all such other lawful acts deeds, and things as incidental and conducive to the attainment of the objects or any one of them.
- e) To acquire, hold, transfer, mortgage, lease out and dispose of and otherwise deal with the property of the Trust in any manner whatsoever and get loans for the fulfillment of the objective of the Trust.
- f) To undertake, carry out promote, sponsor, discharge, fulfill, participate, collaborate, manage or organize the programmes with people's cooperation, the cooperation of national and international governments, and non-government agencies and to carry out all necessary acts for the achievement of the objectives.
- g) All the incomes, earnings, movable/immovable properties of the Trust shall be solely utilized and applied towards the promotion of its Aims and Objects only as outlined in the deed of the Trust and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bouns, or in any manner whatsoever to the present

or the past member of the Trust or any person claiming through any one or more of the present or the past member of the Trust shall have any personal claim on any movable or immovable properties of the Trust or make any profits, whatsoever, under his/her membership.

- h) To accept the loan, grant-in-aid, a donation (either in cash or kind), subsidy or other assistance lawfully, either from national and/or international agencies for the attainment of the objective of the Trust.

BOARD OF TRUSTEES:-

- i. The management and the control of the Trust and its properties shall vest in the Board of Trustees. The Board of trustees shall comprise of minimum three and a maximum of eleven Trustees including the Settlor.
- ii. There shall be two categories of Trustees, i.e "Life Time" and "Associate" Trustees.
- iii. Life Time Trustee will hold office for a lifetime. A life Time Trustee shall cease to hold office only event mention in clauses 1,2,3 and 4 under Para termination of office of the trustees. A Life Time Trustee may nominate any person as his nominee during his holding of office as "Life Time Trustee" as required in the appointment/nomination of the new Life Time Trustees.
- iv. Associate Trustees will hold office for two years or such lesser period as the "Board of Trustees" may decide from time to time but shall be eligible for reappointment in the manner stated in THESE PRESENTS.

LIFETIME TRUSTEE:-

MR. PANKAJ PRATAP and Mr. PAWAN PRATAP shall be lifetime Trustees.



APPOINTMENT OF THE NEW TRUSTEES.

If any Trustee of these presents dies and/or desire to retire or refuse to or become incapable to act in the Trust or take the benefit of insolvency law for the time being in force or become of an unsound mind or bankrupt or insolvent, or otherwise be in force or become of an unsound mind or bankrupt or insolvent, or otherwise be disqualified by operation of law or if any Trustees without leave of absence remains absent from three consecutive meetings of the Board of Trustees, then in every such case it shall be lawful for the serving or continuing Trustees for the time being of These presents to appoint new Trustee or Trustees in place of the trustee or trustees should living or desiring to retire or refusing or becoming incapable to act or taking the benefit of the insolvency law, or failing at attending three consecutive meetings of the trustees without leave given and upon every such appointment or vacancy, the number of trustees for the time being or these presents shall not be less than three and more than eleven. Any vacancy occurrence/crated in the position of "lifetime trustee or trustees" because of any reason, the position shall be filled by the direct nomination by the outgoing trustee (lifetime trustee). In the event of one of the "lifetime trustees" is not alive or mentally not capable of making a decision, in such case the available "lifetime trustee" will make a nomination. Otherwise, it shall be appointed by the "Board of Trustees". In the future "lifetime trustee" nomination/ appointment shall follow the same rule as mentioned above.

SELECTION AND APPOINTMENT OF NEW TRUSTEES:

Upon every appointment made in pursuance of the last foregoing clauses thereof, the newly appointed trustees shall have all powers and authorities of the outgoing trustees under These Presents.

NUMBER OF TRUSTEES:

The number of Trustees including the Author of the Trustees shall not be less than 3 (Three) and not more than ~~11~~ (eleven) persons. The Board of Trustees shall nominate and invite person/ persons to be the other trustees for such a period, as they may deem fit and proper.



TERM OF OFFICE OF THE TRUSTEES:

These trustees shall hold office for such duration as may be specified by the board of trustees.

THE PRESIDENT

1. The President shall be appointed/ nominated among any Life Time Trustee.
2. The President shall preside at the meetings of the managing committee of the trust when he is present and shall exercise such other powers as are conferred upon him by these rules.
3. The President may call for an emergency meeting at short notice if the situation warrants.
4. The President marks a resolution and that shall be conclusive unless such a declaration is challenged and a poll is being demanded the same shall be taken in such a manner as the president may in discretion determine.
5. In case of the President shall be exercise and second or caste vote.

MANAGING TRUSTEE

1. The Managing Trustee shall be appointed/nominated among any Life Time Trustee.
2. There shall be Managing Trustee for the administration of this trust.
3. The Managing Trustee shall head the day to day execution of the Trust. He shall guide and supervise the various activities of the Trust. The ruling of the Managing Trustee shall be final and binding on any question raised at the meeting.
4. The Managing Trustee shall have the rights to call meetings of the Board of Trustees, and decide the venue, date, and time . The President may advise the Managing Trustee to call such a meeting/s.
5. The Managing Trustee shall preside over the Meeting of the Board of Trustees in absence of President. if in any meeting both of them will not be available, the members of the Board of Trustees present in the meeting shall elect one of them as chairperson of the meeting.
6. The Managing Trustee in case of emergency, may exercise all the powers and perform all functions as required to be exercised and performed under these rules, provided that all such actions taken by the Managing Trustee shall be placed before the Board of Trustees in the next meeting.
7. The Managing Trustee may inspect any institutions belonging to the Trust to see its proper functioning and working.



8. The Managing Trustee shall have the power to spend any amount as per the requirement of the trust.

TREASURER

1. He shall maintain the account in the proper and prescribed form in the register either manually ~~or electronically~~ or both.
2. He shall produce the accounts of the trust before the Managing Committee for approval.

VACANCIES:

Any vacancy among the members of the Board of Trustees may be filled by the above- named trustee or their successors and they shall hold office for such duration as may be specified by the Board of Trustees.

TERMINATION OF OFFICE OF THE TRUSTEES:

A Trustee shall cease to hold office-

1. If he or she dies
2. If he or she mentally ill
3. If he or she resigns
4. If he or she is adjudged insolvent or found guilty of an offense involving moral turpitude.
5. If he or she is found to have acted against the interest of the Trust.
6. If it is ~~unanimously~~ decided by the above-named Trustees that the Trustee's continuation in the office is against the interest of the Trust.
7. Upon expiry of the period up to which the Board of trustees has nominated the trustee.

MEETING AND PROCEEDINGS OF THE TRUSTEES:

1. The Trustees shall ordinarily meet once every three months or as often as may be necessary for ~~the satisfactory conduct~~ of the affairs of the Trust. All the meetings of the Trust shall called by the Settlor cum Director of Trust.
2. Decisions at a meeting of the trust shall be by a majority of the vote.

3. At least seven days previous notice of the meeting shall be given to members for an ordinary meeting and a day's notice for an emergency meeting, provided that in case of urgency if the Director so thinks fit, a resolution can also be passed by circulation. In case the votes are equal, the Settlor cum- Director shall have a casting vote.
 4. One third ($1/3^{\text{rd}}$) of the Board of Trustees would be the Quorum for any meeting.
 5. One of the meetings would be called the Annual General Meeting in which the Audited Statement of Accounts would be presented before the meeting for its approval.

NOTICE:-

7 (Seven) days' notice shall ordinarily be given in writing/electronically for a meeting of Board of Trustees.

QUORUM:

The Quorum for the Meeting of the Board of Trustees shall be $1/3^{\text{rd}}$. This number is required for a meeting adjourning for want of Quorum. A minute book (Physical book or electronically) shall be kept by the Trustees. Minutes of entry into the office of very new trustee and of all proceedings of the meeting of the board of trustee shall be entered in the minute book (physical book or electronically) and shall be signed by the chairperson of the meeting.

VOTING:

Decisions of the Board of Trustees may be made at a meeting or by the circulation of papers to them. Normal matters of routine nature may be circulated and decision obtained. The important matters are to be decided at the meeting. All matters arising for disposal shall be decided by a majority of the Board of Trustees present at the Meeting. The chairperson of the Board of Trustees shall have a casting vote in the event of an equality of votes, in addition to his own.

POWER, FUNCTIONS AND DUTIES OF THE TRUSTEES:

All property of the Trust Movable or Immovable of any other kind shall vest in the trust, the trustees shall manage the whole property and affairs of the trust and

shall have all powers, duties, and functions necessary, proper and incidental to the promotion and carrying out of the objects of the trust.

In particular and without prejudice to the generality of the foregoing the trustees shall for this trust have the following powers, duties, and functions:

1. To acquire by Gift, Grant, Purchase Exchange, Lease, or otherwise, lands, buildings, or other immovable properties and also any Movable property.
2. To construct and maintain buildings to alter, to demolish or improve them and equip them suitable.
3. To accept gifts, donations, endowment, and contributions for the Trust and shall be treated as the income of the Trust.
4. To raise loans, to receive monies, securities, or other movable property on behalf of the Trust.
5. To accept any trust, trust fund of endowment so long as the provisions of such Trust of the endowment align with the objects of this Trust.
6. To award scholarship and make donations calculated to promote the objects of the Trust.
7. To enter into contracts or engagements on behalf of the Trust.
8. To consider such proposals submitted by Sub- Committee appointed by this trust and allocate such fund if necessary as deemed necessary for the implementation of the programmers.
9. To make, sign, and execute all such documents, instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust.
10. To invest such monies and such funds of the trust and to vary the investment as and when it may seem necessary or proper provided that such investments shall be made only upon immovable properties or upon securities as the board of trustee may deem fit, under section 20 of the Indian Trust Act, 1882.
11. To sell, transfer or other wise dispose of any immovable property of the trust provided all the Trustees unanimously resolve that it is in the interest of the trust to do so to sell or lease, mortgage, or otherwise dispose of any movable and immovable properties of the Trust.

12. To appoint Committee/ Committees of management for such terms and with such powers as may be specified from time to time, for carrying on the routine management of the affairs of the Trust.
13. To appoint such employees on such terms and conditions as the Trustees may deem fit for carrying out the work of the trust and exercise and control all such employees including the power of suspension, dismissal, and removal.
14. To delegate to the Managing Trustee or any appointed committee such powers, duties, and functions as are vested in the Trustees.
15. To frame Bye Laws and such other regulations as required for achieving its objectives.
16. Out of the income of the Trust property, the trustees shall be entitled to spend or incur the following expenses namely.
 - a) All rates, taxes, cess, assessments, and duties if any payable to the government or any municipal or other public bodies in respect thereof or any part thereof.
 - b) The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.
 - c) The costs of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.
 - d) the cost of making such additions/ alterations or improvements or in the buildings forming part of the trust property, as the trustees shall think fit.
 - e) Wages and salaries of any manager, supervisor, accountant, clerk servant, or other employees employed by the trustees in the carrying out of this trust.
 - f) Cost and expenses of keeping the trust property in good conditions.
 - g) Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.
 - h) All fees and legal charges payable to other professionals engaged in the course of administration of the trust.
 - i) All other costs, charges, and expenses of and incidental to the management and administration of the trust property following the

objects and purses hereof or which may be incidental thereto. After deducting the costs charges and expenses incurred by the trustees as aforesaid out of the total gross income received by them from the trust property the balance that is the net income will be utilized for the objects of the trust as decided by the board of trustees.

BANK ACCOUNT:

- i. The Trustees may from time to time open and maintain in the name of the Trust any bank accounts as may from time to time be determined by the Trustees and shall forthwith pay or cause to be paid the rents, income, profits, dividends and all other sums of money forming part of the Trust Fund to the credit of any such account or accounts, And that such Account shall be operated by any of the trustee/ trustees as and when decided by the Board of Trustees.
- ii. The trust may open Bank Account/s in the name of the institution/ organization/ entity founded by the Trust. Such Bank Accounts shall be operated by such person/ persons as authorized by the board of trustees from time to time.

APPLICATION OF THE PROPERTIES OF THE TRUST:

The properties and funds of the Trust shall be applied only for the trust and for the due administration of its business affairs and properties provided however that this shall not preclude payment of any remuneration or allowance or giving of residential accommodation or any perquisites to any trustee in connection with the work carried out by him/her for the Trust.

ACCOUNTS:

The Trustees shall maintain a true and correct record of the receipts, payments incomes and expenses, and transactions of the Trust. The Books of Account of the trust shall be audited by a qualified auditor or a chartered accountant every year i.e. commencing from 1st April to the 31st March of next year.



DEFECTS OF PROCEDURE IMMATERIAL:

No act of Trustees shall be invalidated by reason only of any vacancy in the Board of Trustees or any irregularity in the proceedings or the Board of Trustees or any committee thereof.

AMENDMENTS:

No amendments to the trust Deed shall be made which may prove to be repugnant to the provisions of section 2(15), 11, 12 and 13, and 80G of the Income Tax Act, 1961 as amended from time to time.

DISSOLUTION:

In the event of dissolution or winding up of the Trust, the assets of the trust remaining on the date of dissolution shall under no circumstance be distributed among the Trustees, but the same shall be transferred to any other Trust, Society, Association or Institution whose objects are similar to those of this Trust.
